

**2024 APPLICATION CONDITIONS FOR FOREIGN STUDENTS WHO WILL BE  
ADMITTED TO ESKİŐEHİR TECHNICAL UNIVERSITY'S ASSOCIATE  
DEGREE/UNDERGRADUATE PROGRAMS BY USING HIGHER EDUCATION  
ENTRANCE AND PLACEMENT EXAM, INTERNATIONALLY VALID EXAM  
RESULTS, INTERNATIONAL DIPLOMA GRADE**

In order to study at the associate/bachelor's degree level in our University's departments/programs in the 2024-2025 academic year, candidates who have graduated from a school equivalent to a Turkish high school and who meet the following application conditions must take the TR YÖS Exam for International Students to be Admitted to Eskiőehir Technical University's Associate/Undergraduate Programs; or they must apply with internationally valid exam results/diploma specified in the "Directive on Application, Admission and Enrollment for Students to be Admitted to Eskiőehir Technical University Associate/Undergraduate Programs from Abroad", which was accepted by the decision of Eskiőehir Technical University dated 04/01/2024 and numbered 1/3.

**Application Conditions**

- A) Among the candidates who are in their final year of high school or continuing their education at equivalent schools or who have graduated from these schools, those who have the following characteristics are accepted:
- a) Citizens of foreign countries [provided that those who continue their education in secondary education (high school) institutions in Turkey have registered before the 2022-2023 academic year (Excluding embassy schools and international private education institutions in the MOBİS system and foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education)],
  - b) Those who were citizens of a foreign state and became Turkish citizens through acquired citizenship later/dual citizens in this situation [provided that those who continue their education in secondary education (high school) institutions in Turkey were registered before the 2022-2023 academic year],
  - c) Turkish citizens who completed their entire secondary education (high school) in a foreign country other than TRNC [including those who completed their entire secondary education (high school) in Turkish schools opened under the Ministry of National Education in a foreign country other than TRNC],
  - d) Those who are TRNC citizens, reside in TRNC and have completed their secondary education (high school) in TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results after registering and getting education in colleges and secondary education (high school) institutions in other countries between 2005 and 2010,

- e) Those who were Turkish citizens by birth but lost their Turkish citizenship by obtaining permission from the Ministry of Internal Affairs to renounce Turkish citizenship, and those who document that they have a "Blue Card", which is given to those who lost Turkish citizenship upon their request [Provided that those studying in secondary education (high school) institutions in Turkey are registered before the 2022-2023 academic year] (The first paragraph of the 7th article of the Turkish Citizenship Law No. 5901 contains the provision "A child born to a Turkish citizen mother or father within or outside of Türkiye in marriage is a Turkish citizen.")
- B) Applications of those whose situations are stated below will not be accepted for foreign studentship:**
- a) Those who are Turkish citizens and completed their entire secondary education (high school) in Turkey or TRNC,
- b) Dual citizens whose first citizenship is Turkish by birth, as defined in paragraph (d) of Article A (except for those who meet the conditions in paragraph (c) of Article A),
- c) Those who are Turkish citizens and are educated in schools within the embassies in Turkey and foreign secondary education (high school) institutions in Turkey, or dual citizens whose first citizenship is Turkish by birth, in accordance with subparagraph (d) of the first paragraph of Article A,
- d) TRNC citizens who enroll in secondary education institutions in Turkey starting from the 2022-2023 academic year and those who renounce Turkish citizenship/Blue Card holders and foreign nationals (except the foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education, embassy schools and international private education institutions in the MOBİS system).

### **MINIMUM CONDITIONS REQUIRED FROM CANDIDATES WHO MEET THE APPLICATION CONDITIONS**

Candidates can apply for placement at the University with the "Exams with the status of Higher Education Institutions Examination (validity period of 2 years)", "High School Diploma Grade or High School Graduation Exam Result", and TR-YÖS result, which are accepted by Eskişehir Technical University in recruiting foreign students. Information regarding "Exams with the status of Higher Education Institutions Examination (validity period of 2 years)", "High School Diploma Grade or High School Graduation Exam Result" and "Foreign Student Selection Examination" and candidate qualification levels are given below.

### Exams with the status of Higher Education Institutions Exam

<b>ACT:</b> Exam for those who want to study at a university in the United States (American College Test).	Having a total score of at least 21 from the Science Reasoning and Math tests on the ACT.
<b>GAOKAO:</b> The exam held for those who want to study at a university in the People's Republic of China.	Having received at least 480 points out of 750 in the score type of the program applied for in the Central University Entrance Examination (GAOKAO).
<b>SAT 1:</b> Exam for those who want to study at a university in the United States (Scholastic Aptitude Test).	Having scored at least 550 from Mathematics; and having scored at least 1000 points Mathematics + Reading in the SAT 1.

<b>ABITUR:</b> German high school graduation exam.	Having received 1-4 points from the ABITUR exam as an exam grade. (FACHABITUR applications without an exam will not be accepted.)
<b>Apolytirion of Lykeo/Secondary School Leaving Certificate:</b> Greece diploma grade.	Having received at least 10 points out of 20 in the Greece "Apolytirion of Lykeo/Secondary School Leaving Certificate" diploma grade.
Certificat d’Enseignement Secondaire Supérieur/Diploma (previously Getuignschrift) van Hoger Secundair Onderwijs/Abschlusszeugnis der Oberstufe des Sekundarunterrichts: Belgian High School Completion Diploma.	Having a diploma grade of at least 14/20 from Belgium Certificat d’Enseignement Secondaire Supérieur/Diploma (previously Getuignschrift) van Hoger Secundair Onderwijs /Abschlusszeugnis der Oberstufe des Sekundarunterrichts.
<b>DIPLÔME DU BACCALAUREAT GENERAL:</b> The exam taken to get a university education in France.	DIPLÔME DU BACCALAUREAT GENERAL (French Baccalaureate), Having received at least 12 points out of 20 in the diploma grade in the branch related to the program.
<b>GCE AL:</b> Exam to receive university education in the Turkish Republic of Northern Cyprus (TRNC) (General Certificate Education–Advanced Level).	Those who are TRNC citizens, reside in TRNC and have completed their secondary education in TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by enrolling and receiving education in colleges or high schools in other countries between 2005 and 2010.

<b>GCE:</b> Exam for those who want to study at a university in England (General Certificate Education).	Having received A level scores in GCE (A level) in at least two subjects, at least one of which is related to the applied department/programme.
<b>MATURA:</b> High school graduation exam for those who want to study at a university in Austria.	Having received 1-4 points from the Austrian MATURA (Matura Reifezeugnis) exam.
<b>MATURA:</b> High school graduation exam for those who want to study at a university in Switzerland.	Having a Swiss MATURA diploma grade of at least 4-6.
<b>VWO Certificate (Voorbereidend Wetenschappelijk Onderwijs ≡ Secondary School Leaving Certificate)/HAVO (Hoger Algemeen Voortgezet Onderwijs ≡ Senior General Secondary Education):</b> Dutch High School Completion Diploma.	Having received at least 6 out of 10 points from one of the diplomas of Dutch VWO Certificate (Voorbereidend Wetenschappelijk Onderwijs ≡ Secondary School Leaving Certificate)/HAVO (Hoger Algemeen Voortgezet Onderwijs ≡ Senior General Secondary Education)

#### **b) Foreign Student Examination (YÖS)**

TR-YÖS	Candidates who score at least 50 out of 100 in programs/departments can apply for placement at the University.

The validity period of ACT, GAOKAO, SAT 1, which have the status of Higher Education Institutions exam, and TR-YÖS is 2 (two) years.

Candidates can apply for the announced quotas with any of the following documents, provided that they receive any of the scores stated above:

- “High School Diploma Grade” document,
- “High School Graduation Exam Result” document,
- The result document of an exam held abroad and accepted as "Higher Education Institutions Examination",
- TR-YÖS result document.

Except for TR-YÖS result documents, students are not accepted to Eskişehir Technical University with YÖS-like exam results conducted by other higher education institutions in Türkiye.

The issues to be taken into account in the evaluation of candidate applications to departments/programs that will accept students from abroad, placement in programs and enrollment processes are as follows:

- a) The process will be carried out through the University's Student Affairs Department, Information Technology Department, Examination Unit and International Relations Unit.
- b) Candidates can choose a maximum of 3 (three) departments/programs. The placement process will be carried out according to the conditions of the department/program preferred by the candidates.
- c) If necessary, quota transfer and/or additional placement can be made between departments/programs for which applications have not been made or whose quotas have not been filled.
- d) Candidates who meet the application conditions will be ranked according to their scores.
- e) Candidates who are citizens of the same state will be placed in the relevant departments/programs according to their preferences, provided that they do not exceed 20% of the quota determined for the applied program. This rule will not be applied if the program quota remains empty.
- f) Candidates with dual citizenship must declare their preferred citizenship information when filling out the online application form.
- g) In case of equality in the ranking, firstly the preference order of the candidates, then their secondary education success grade, and then their age (priority is given to the younger ones) will be taken into consideration.
- h) If the candidate acquires citizenship of another state other than Turkish citizenship after completing the application process on the University's website, he/she may request a change in the citizenship category. Apart from this, preference, enroll and diploma procedures will be carried out based on the citizenship specified during the application.
- i) If the candidate, after gaining the right to enroll in a program, cannot document the passport/identity information regarding the citizenship he/she specified in the application during the program enrollment process, he/she will lose his right to enroll.
- j) If the candidate who has the right to enroll does not enroll within the announced period, or if it is determined that he does not meet the application conditions during the control of the enrollment documents and applied with an improper document, his enrollment will be deleted even if he has enrolled.
- k) Students who will apply to departments/programs that accept students through "Pre-enrollment/Special Aptitude Examination" must be successful in the "Special Aptitude Examination" held by the relevant department/program, in addition to meeting the condition of obtaining any of the scores mentioned above.
